Summary.	Papers reflect the professional careers of Charles E. Coates and his son, Jesse Coates, professors of chemical engineering at Louisiana State University. The collection also contains family papers of Charles Coates and Ollie Coates. Those of Ollie Coates reflect her involvement in The Baton Rouge Theater Guild. Collection consists of correspondence; scientific reports and writings; academic material; family photographs.

BIOGRAPHICAL/HISTORICAL NOTE

Charles E. Coates was born in Baltimore, Maryland in August 1866. His father, Charles E. Coates, Sr., practiced medicine in Baltimore after moving from Coatesville, Pennsylvania. As a youth, he attended Westtown Boarding School in Chester County, Pennsylvania, and studied in Germany from 1888 until 1891. In 1893, he received a PhD in chemistry from Johns Hopkins University in Maryland, and accepted a position at Louisiana State University in the Department of Chemistry. At LSU, he distinguished himself in the field of sugar chemistry and engineering. At the time of his appointment, he was the third faculty member with a PhD in the history of the University. During his tenure, he served as head of the Department of Chemistry, dean of the Audubon Sugar School, and chair of the Graduate Division. Coates was recognized worldwide for his work in sugar chemistry research.

Coates is also known for serving as the first football coach at LSU. He played football at Johns Hopkins University. When he arrived at LSU, he organized the University's first football squad. He lost the only game he ever coached in 1893 to Tulane, 34-0.

He married Ollie Maurin in 1901, and they had four children: Charles Hunter (1903-1972), Victor Maurin (b. 1905), Jesse Penncock (1908-1994), and Caroline Penncock (b. 1917). Coates retired from LSU in June 1937. He died December 27, 1939 at the age of 73. Coates Hall on the LSU campus was built in 1924, and named in honor of his distinguished career as a member of the faculty at the University.

Ollie Maurin, of Donaldson, Louisiana, was born July 28, 1882. She attended Belhaven College, a liberal arts college for women in Jackson, Mississippi. She was a long-standing member of St James Episcopal Church in Baton Rouge, serving in many capacities. As the historian for the Episcopal Church of Louisiana, she compiled a booklet commemorating the first 100 years of St. James Episcopal Church. In addition, she was active in several historical societies and women's clubs, as well performing with the Baton Rouge Little Theater Guild in the 1920s. Ollie was also served on the board of the Baton Rouge Branch of the American Association of University, Louisiana Division. Ollie died on July 18, 1981.

Coates's youngest son, Jesse Penncock Coates, followed him into the academic community. He received a Bachelor of Science degree in chemical engineering from LSU, and went on to obtain a Master of Science degree (1932) and a Ph.D. (1936) from the University of Michigan. He began his LSU career on the faculty of the Chemical Engineering Dept. under the leadership of Dr. Paul M. Horton. During World War II, he served as interim head of the department while Horton was away working on a high priority project. Distinguished in his field for his research, he earned several honors as an expert in the areas of thermodynamics, distillation, and physical properties of materials. He authored and co-authored numerous scientific papers and articles. Coates retired from LSU in 1973, and died in 1994.

Charles Hunter Coates, the eldest son of Charles E. Coates, graduated from United States Military Academy at West Point in 1924, with a commission of second lieutenant. He served

in the infantry for twenty-five years until his retirement in 1949. His military service included a variety of commands and staff assignments both in the United States and abroad. Locations included China, England and France during World War II, and Japan during the U.S. occupation. Charles married Evelyn Crutchfield of Columbus, Georgia, in 1931. They had a son, Charles Hunter, Jr., (b. 1935) and a daughter, Patricia Mae (b. 1944). After his retirement in 1949, Charles returned to LSU where he earned a M.A. in Psychology and a Ph.D. in Sociology. In 1955, he joined the faculty of the Department of Sociology at the University of Maryland, College Park, Maryland, serving there until his death in 1972.

Caroline Penncock Coates received a Bachelor of Arts in design from Sophie Newcomb College in New Orleans in 1938. She also studied at the Pennsylvania Academy of The Fine Arts, in Philadelphia, and the Arts Students League in New York City. She later returned to Louisiana to complete her post-graduate work in art education at LSU. Her watercolor titled *Neighbors*, which was displayed in the New Orleans Delgado Museum, received the Centennial Award in 1942. In 1943, Caroline married U.S. Army doctor, Elisha Blassingame Spiller. Spiller was stationed at Letterman Army Hospital near San Francisco, Calif. The couple resided in the area and raised three children.

SCOPE AND CONTENT NOTE

Papers reflect the professional careers of Charles E. Coates and his son, Jesse Coates, professors at Louisiana State University. The collection also contains family papers of Charles and Ollie Coates. Those of Ollie Coates relate to her involvement in the Baton Rouge Theater Guild. Correspondence; scientific reports and writings; academic material; family photographs, and printed items comprise the collection.

Professional papers of Charles Coates relate to his research in agricultural chemistry, with an emphasis in sugar. They consist of correspondence, analytical files, and scientific writings. Family papers are comprised of correspondence, personal papers and printed items, which relate mostly to Coates, but include some correspondence and papers relating to his children Charles Hunter and Caroline Penncock. Letters report on family news, current events and personal activities. A large part of the personal papers pertains to the estate of George W. P. Coates and property in Cedar County, Neb (1925-1954). The papers of Ollie Coates reflect her interest in theater and literature, education, religion, local and state history and her involvement the Baton Rouge Little Theater Guild. The papers of Jesse Coates reflect his role as an educator and researcher in the field of chemical engineering. They document his contribution to the development of programs, examinations for professional engineers and in the planning and construction of a new addition to the LSU chemical engineering building. Papers include correspondence, instructional material, scientific writings, grant proposals and reports.

SERIES DESCRIPTIONS

Subgroup 1. Charles E. Coates Papers, 1862-1966, undated.

Series I. Professional Papers, 1887-1958, undated.

Subseries 1. Correspondence, 1905-1940, undated.

This subseries illustrates Charles Coates's role as a prominent chemist and professor of chemistry. Letters reflect the wide range of research projects in which Charles Coates was involved as an expert in the field of chemistry on the faculty of Louisiana State University. Correspondents include oil producers, manufacturers, federal agencies, and members of the agricultural and lumber industries, as well as members of professional and trade associations. In their letters, they discuss research, analyses and reports. A large part of this series pertains to research performed at the Audubon Sugar School and Institute of Industrial Research at LSU. The bulk of the correspondence occurs during the 1930s. A series of letters relate to Coates's attempt to patent a method of manufacturing bagasse chairs (1920-1924).

Coates also corresponded with colleagues, politicians and former students. In a letter to LSU president, Col. Thomas D. Boyd, Coates submits statistical data on students enrolled in the Audubon Sugar School and the Department of Chemistry (March 9, 1921). A former student, H. S. Chaturvedi, while requesting a reference for employment, also reports from Cawnpore, India, on local Hindu-Muslim violence (March 11, 1939). Coates writes to Senator John Overton about the labor legislation in Cuba, and he relates his own views on the international political environment (July 27, 29, Sept. 1, 1937).

Note: Professional correspondence is also be found in related analytical data files.

Subseries 2. Analytical Data Files, 1901-1938, undated.

This series contains analyses, scientific reports, legal documents, correspondence and notes on research projects conducted by Charles E. Coates, Audubon Sugar School and Institute of Industrial Research. Files reflect research into various Louisiana agricultural products, particularly sugarcane. The University also performed studies at the request of industry. For instance, Coates studied possible oil contamination of Louisiana oyster beds at the request of the Texas Company in preparing for a civil suit (1932-1936).

Note: Files are arranged in alphabetical order by topic; contents within folders are arranged in the original order of the creator.

Subseries 3. Writings, 1887-1938, undated.

This subseries consists of addresses and papers delivered at conferences, drafts of articles, research notes, class lectures, and notebooks. They relate to petro-chemical and sugar research. Also found is Grace R. Cameron's bibliography of Coates's publications. Additionally, Coates reports on the need for adequate equipment for students (ca. Nov. 1922). Several papers relate to the work of the Institute for the Industrial Research (1927-1937, undated).

Note: Files are arranged in alphabetical order by topic.

Subseries 4. Student Files, 1893-1937, undated.

This subseries is comprised of assigned problems, analyses, and reports submitted by students to Charles E. Coates. Lists of students and graduates enrolled from 1893-1937 can also be found (undated).

Subseries 5. Printed Items, 1891-1959, 1984, undated.

A large part of this subseries is comprised of newspaper clippings (1912-1959, 1984) and reprints of published articles on sugar research; Charles E. Coates authored some. Material also includes sugar patents (1891-1921), research authored by other scientists, and ephemera. Newspaper clippings report on Charles Coates' career and the sugar industry (1912-1959, 1984, undated). Clippings contain several articles on the return of the U. S. Army, 15th Infantry to Tacoma, Wash. from a tour in China (March 1938). An issue of the LSU University Bulletin provides a history of the Audubon Sugar School (Oct. 1909) and a brief sketch of LSU (Feb. 1922).

Series II. Family Papers, 1862, 1870-1966, undated.

Subseries 1. Correspondence, 1862, 1888-1966, undated.

This subseries consists of personal letters exchanged with family members, friends and acquaintances, with the largest part being that of Charles E. Coates (1888-1939). Letters report on family news, current events and personal activities. They include a Civil War letter (1862; photocopy-no original) and family letters written when Coates was a young man, studying in Germany (1888-1891; photocopies-no originals). World War I letters relate the wartime activities of a former student and a family member (1917-1919). Coates exchanges letters with British friend, "Johnnie" Ashmore, in which they discuss the political events in Europe and India, and the Second Sino-Japanese War (1937-1939). Coates also provides Ashmore with the details of the scandal surrounding LSU President, James M. Smith (Aug. 10, 1939). Correspondence also reflects Charles Coates's involvement in the financial affairs of his sister-in-law, Lillian Maurin Breckinridge Sanford, and the financial interests of her minor children (1921-1937). Letters from friends and colleagues offer their congratulations upon his retirement (1937).

The correspondence of Ollie Coates relate to family matters, financial, and business affairs (Oct. 1, 1922-1928, 1939-1960), and her interest in the dramatic arts (1927-1928).

In his letters, Charles Hunter Coates describes military assignments and military life (1955-1959). He comments on locations in the northwestern part of United States and China during the 1930s. Letters concerning Caroline Coates relate to her education and career in art education (1941-1942).

Subseries 2. Photographs, 1866-1957, undated.

Family photographs consist of card photographs and snapshots. They include a carte de visite of Charles E. Coates as an infant and copy prints of him as a young man at Johns Hopkins until his retirement in 1937. Images of family members include Ollie Coates (undated), Frank T.

Coates (1818), Victor Maurin (1877), Charles Hunter Coates (1935), and pictures of his infant son Charles, Jr. (1935). Photographs of Louisiana plantation houses are found among the snapshots (1928). Card photographs provide images of the chemistry laboratory and Pentagon Barracks on the old LSU campus in downtown Baton Rouge (1893). The photographs taken by Charles Hunter Coates depict the death and destruction in China during the Second Sino-Japanese War (1937).

Subseries 3. Personal Papers, 1883-1963, undated.

This subseries is comprised of business and financial papers, writings, printed items and ephemera. A large part of this group relates to the estate of George W. P. Coates and land in Cedar County, Neb. (1925-1954). Business papers also include leases for a residence on Boyd Ave. and probate court documents (1922). Receipts and accounts for goods and services reflect everyday expenses. Miscellaneous items include prose and poetry written by Charles Coates (1883-1901), newspaper clippings of world events (1938-1939), and Coates's retirement (1937). Also found is a short biographical sketch of Woodrow Wilson (ca. 1919). Several newspaper clippings and journal articles pay tribute to Coates after his death (Dec. 1939-May 1940). Several travel logs list expenditures of trips taken (1932-1934, 1959, undated). Personal papers also contain biographical sketches of Coates and Caroline Coates (undated), his handwritten will (Sept. 19, 1903), and a paper presented by Charles Hunter Coates at a meeting of the American Sociological Society (Aug. 27, 1957).

Subgroup 2. Ollie Maurin Coates Papers, 1881-1973, undated.

Series I. Writings, 1899-1900, 1927-1971, undated.

Writings consist of literary works, speeches, and notes by Ollie Coates that reflect her interest in theater and local history, and her involvement with the Baton Rouge Little Theater Guild. Also found is Ollie's class notebooks from Belhaven College (1899-1900). Scrapbook pages of newspaper clippings contain articles on Ollie Coates, Charles Coates, social events, house designs and poetry (1895-1909). There is also a draft copy of her biography on her husband, Charles E. Coates (ca. 1959). A small notebook relates to the Woman's Auxiliary of St. James Church of Baton Rouge (1955-1956) and St. James Executive Board (1955-1956). Another notebook contains notations on children's plays (undated). Also found are drafts of the *History of the American Association of University Women* (1962), and reports and notes on the American Association of University Women (AAUW).

Series II. Printed Items, 1881-1973, undated.

Subseries 1. General, 1914-1973, undated.

This subseries is comprised in a large part of programs for the Little Theatre Guild of Baton Rouge and the LSU University Theater (1921-1937). Newspaper clippings and ephemera relate to theater productions. Also found are the by-laws of the Little Theater Guild (1922) and a *Descriptive List of Religious Plays and Pageants*. The Commission on Religious Drama produced this list to illustrate plays of high moral standards (ca. 1926). There is also map of Baton Rouge neighborhoods in the 1930s.

Subseries 2. Playbooks, 1881-1938, undated.

Scripts considered or performed by the Baton Rouge Little Theater Guild. Also present are several playbooks for Easter pageants (1917-1931, undated). Of note is a script of *The Man who died at Twelve O'clock: A Negro Comedy in One Act* (1927).

Note: Playbooks are arranged by title; see appendix A for an alphabetical list of titles.

Series III. Photographs, 1917, 1920, undated.

Photographs depict actors on stage in Baton Rouge Little Theatre Guild productions (1920). Of note are two photographs showing actors in black face. Also included is a group photograph of the Baton Rouge Music Club (1917).

Subgroup 3. Jesse Coates Papers, 1932-1981, undated.

Series I. Student-Faculty Files, 1932-1980, undated.

Subseries 1. Students, 1936-1980.

Student files contain quizzes, exams, problems, reports, printed items and correspondence related to class projects and assignments.

Note: Folders are arranged by class numbers; folder contents are arranged in the original order of the creator.

Subseries 2. Faculty, 1932-1974, undated.

Chemical engineering problems with their solutions comprise a large part of this series. Problems were developed for use on exams for graduate students and graduates applying for a professional license. Papers also include material related to the development of academic standards and programs.

Series II. Correspondence, 1947-1975, undated.

Correspondence pertains to the funding and construction of an addition to the Chemical Engineering building (1966-1973); names of LSU buildings and facilities (1968-1972); academic programs and exam problems. Correspondence with the National Council of Engineering Examiners discusses the licensing exam for engineers. There is also some discussion on the environment (1973).

Series III. Writings, 1941-1981, undated.

Subseries 1. Jesse Coates, 1941-1967, undated.

This subseries includes lectures, scientific papers, journal articles, notes and mathematical calculations. Articles authored or co-authored by Coates include a collection written for the *Chemical Engineering Refresher* series. Additionally, there are notes and drafts of *Chemical Reactor Design*, a textbook co-authored by Coates.

Note: Folders are arranged alphabetically by title.

Subseries 2. Faculty, 1932-1973, undated.

This subseries includes draft and final copies of addresses and research papers written by colleagues, and reports on research done by Ph.D. candidates. Also, found are articles that were published in the journal, *Chemical Engineering* (1953-1961). Related correspondence, notes and calculations accompany some of the writings.

Note: Folders are arranged alphabetically by title.

Series IV. Proposals and Progress Reports, 1964-1972.

This subseries consists of grant proposals for research projects (1964-1971) and the construction of an addition to the Chemical Engineering building (1966-1972). Papers pertaining to the construction include drawings, blueprints and blue line prints. Submitted proposals include *Research in Weapons Systems Effectiveness* (1964, 1968), *Measurements, Correlation and Prediction of Transport Properties of Liquids and Solutions* (1968), *Removal of SO₂ from Gaseous Streams by Hargreaves Reaction* (1970-1971), *Specialized Research Equipment for the Transport Properties of Fluids* (1967-1969), *A Study of Transfer Coefficients ...* (1966), and *Use of Sucrose in the Preparation of Fire Retardant Compounds* (1971). Reports update University officials and funding organizations on the progress and results of projects. University self-study reports are also found (1963, 1965, 1970).
